



Internet Online Services User Manual

DEFINITION

Evans Transportation Services, Inc. ("Evans") provides an interactive on-line service operated by Evans on the World Wide Web of the Internet ("Evans web site"). "Subscriber" means each person who establishes or accesses a connection ("Account") for access to and use of Evans web site.

CHANGES

Evans Transportation Services, Inc. shall have the right at any time to change or discontinue any aspect or feature of Evans web site, including, but not limited to, content, hours of availability, and equipment needed for access or use.
